Recognising the urgency of the climate crisis, we strive to lead the construction sector in sustainable practices, embedding innovation and accountability at every level of our business.

Strategic Alignment and Standards

Our carbon management system adheres to PAS 2080:2023 Carbon Management in Buildings and Infrastructure, ensuring rigorous monitoring, measurement, and reduction of emissions. Additionally, we align with key frameworks, including:

- National Highways' Environmental Sustainability Strategy
- National Highways' net zero 2030 / 2040 / 2050 plan

These standards guide our actions and ensure compliance with the latest industry expectations, reinforcing our role as a forward-thinking contractor.

Targets and Accountability

Freyssinet is proud to align with the VINCI Group's ambitious global sustainability goals. Our specific targets include:

- Scope 1 & 2 emissions: Reduce by 40% by 2030 (baseline: 2021)
- Scope 3 emissions: Reduce by 20% by 2030 (baseline: 2022)

These objectives are reviewed annually, with new reduction strategies developed as needed. Our Senior Leadership Team holds ultimate responsibility for driving these initiatives and ensuring compliance with all relevant policies.

Engagement and Collaboration

We proactively assess our operations to identify key sources of greenhouse gas emissions and engage with employees, customers, and suppliers to raise awareness of the climate emergency. Collaboration is at the heart of our approach:

- Clients: Exceeding their carbon emission targets through innovative project solutions.
- **Suppliers and subcontractors:** Partnering to reduce emissions across the supply chain.

Innovation in Action

Freyssinet leverages on innovation and digital tools, such as the National Highways' Carbon Tool, to quantify, track, and reduce emissions across projects. We prioritise:

- Incorporating low-carbon materials and designs.
- Exploring renewable energy solutions.
- Enhancing operational efficiencies throughout the project lifecycle.
